- (vii) To organize Skill Development Programs in collaboration with industry.
- (viii) To facilitate faculty to carry out Research & Development Project in association with the industry.
- (ix) To arrange specialized lectures on entrepreneurship for students by the industry experts.
- (x) To organize Conferences/ Seminars/ Workshops/ Exhibitions/ Start-up Initiative Meets/ Hackathons in association with the industry.
- (xi) Any other activity, needed from time to time for the academic enrichment of students and faculty, by associating industry.
