Memorandum of Understanding

and

Humanities and Social Sciences, JIIT, Noida

PREAMBLE

This Memorandum of Understanding (MOU) is entered into by the **English Language Teachers' Association of India** hereafter '**ELTAI**' and '**Humanities and Social Sciences, Jaypee Institute of Information Technology, Noida**' with a registered address at **A-10, Sector-62, Noida-201 309, Uttar Pradesh, India-** and are referred to collectively, as "Parties" or individually as "Party."

Aims:

To cultivate the habit of reading among our learners for joy and on their own volition.

To motivate them to become autonomous readers, leading to lifelong learning.

Roles and Responsibilities

ELTAI

- 1.1 To provide 100 modules on different genres and reading strategies.
- 1.2 To train 03 Mentors identified by the institution through Dean & HoD, HSS, Prof Alka Sharma biannually

either in-person or online.

- 1.3 LMS and an exclusive website to share the materials and record events of the different institutions.
- 1.4 To create a reading profile of each student by tracking their progress from the beginning and enable them to become effective readers. (to be part of the portfolio)

Institution

- 2.1 To identify 03 mentors to be in constant touch with the ELTAI team dedicated for the implementation of the movement.
- 2.2 To provide a reading corner with a bookshelf.
- 2.3 To encourage students to maintain a logbook (portfolio) to record the details of the titles read and carry out the suggested tasks.

Duration

- 3.1 This MoU shall be effective for a period of three (3) years from the date of the final signature. It may be modified or extended by mutual written agreement by the Parties. This MoU may be terminated by either party upon six (6) months advance written notice.
- 3.2 It is expressly agreed that the First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the
